

Cassia County Joint School District No. 151 Board of Trustees has established attendance zones to facilitate the district's educational programs by regulating attendance, as efficiently as possible, at the various school buildings. Such zones are subject to annual review as deemed necessary by this board.

A student will attend school in a building serving his or her attendance zone. The student's attendance zone is based on his or her residence at the time of enrollment. The student's residence is the address of the parent or guardian enrolling the student. Proof of residency may be required. If the parent or guardian moves to a different attendance zone, the student will be transferred to the appropriate building. However, the superintendent is authorized to permit a student to complete a grading period in the initial attendance zone when such action is deemed to be in the best interest of the student.

All requests for an intra-district transfer must comply with the district's Open Enrollment policy. Deviation from this policy may occur for district staff and the education of special needs children and their siblings.

The attendance zones for this district are as follows:

**HIGH SCHOOL:** After enrolling in and attending one high school in the district, student will not be permitted to transfer to another district high school without prior approval from the superintendent or designee. Such approval will normally be granted immediately if the student's parent/guardian moves from one attendance area to another., The district will not accept responsibility for transportation of any student who is not attending the high school of his/her attendance areas. The district may permit transfer of enrollment if requested prior to the end of the first week of the school year.

**BURLEY ATTENDANCE AREAS:**

**JOHN V. EVANS ELEMENTARY SCHOOL** – Students in grades K-6 residing within the following boundaries: *See Map*

**MOUNTAIN VIEW ELEMENTARY SCHOOL:** Students in grades K-6 residing within the following boundaries: *See Map*

**DWORSHAK ELEMENTARY SCHOOL:** Students in grades K-6 residing within the following boundaries: *See Map*

**WHITE PINE INTERMEDIATE SCHOOL:** Students in grade K-6 residing within the following boundaries: *See Map*

**BURLEY JR. HIGH & HIGH SCHOOL:** Students residing within the following boundaries: Beginning 1375 west and Snake River; south to 200 south; west to 1400 west; south to 400 south; west to 1100 west; south to 800 south; east to 800 west; south to 1000 south; east to 400 west; north to 850 south; east to 50 west; south to 1400 south; east to Mountain Range. Follow

Mountain Range northeast to 650 east; north to Snake River; Snake River west to 1375 west (Point of Beginning).

Jr. High and high school students 250 east to 650 east, river south to Mountain may go to Burley or Declo Schools.

**ALBION ATTENDANCE AREA:**

**ALBION ELEMENTARY SCHOOL:** Students in grades K-5 residing within the boundaries with point of beginning at 1250 E and 200 S, then east side of mountain range to 1500 S, then east to 1550 E, then north to 200 S, then west to point of beginning.

**DECLO ATTENDANCE AREA:**

**DECLO ELEMENTARY SCHOOL:** Beginning Snake River and 250 east; south to 700 south, east to 450 east, south to Mountain Range. Follow Mountain Range northeast to 350 south, east to Interstate 84; south on Interstate to Idahome lane; east to Cassia County Line. North to 400 north; west to 3250 east; south to 200 north; west to 3150 east; south to 300 north; west to 2750 east; north to Snake River. Follow river to 2250 east; south to 400 north; west to 1050 east; north to Snake River. Follow river to 250 east (Point of Beginning).

**DECLO JR. HIGH & HIGH SCHOOL:** Beginning Snake River and 250 east; south to 700 south, east to 450 east, south to Mountain Range. Follow Mountain Range northeast to 350 south, east to Interstate 84; south on Interstate to Idahome lane; east to Cassia County Line. North to 400 north; west to 3250 east; south to 200 north; west to 3150 east; south to 300 north; west to 2750 east; north to Snake River. Follow river to 2250 east; south to 400 north; west to 1050 east; north to Snake River. Follow river to 250 east (Point of Beginning).

Jr. High and high school students between 250 east and 650 east, Snake River south to mountain may go to Burley or Declo School. Also Albion Elementary attendance area jr. high and high school students go to Declo Schools.

**RAFT RIVER JR. HIGH & HIGH SCHOOL:** Students residing within the following boundaries: Beginning 450 east 1400 south, south to Utah line. East to Oneida County line; north to 2700 south; east two miles into Oneida County; north 4 miles; west to Cassia County line; north to 900 south; west to Interstate 84; north on Interstate to 300 south; west to 1450 east; south to 1400 south; east to 450 east (Point of Beginning).

**RAFT RIVER ELEMENTARY SCHOOL:** Students residing within the following boundaries: Beginning 450 east 1400 south; south to 2600 south; east to 1150 east; south to Utah line; east to Oneida County line; north to 2700 south; east two miles into Oneida County; north 4 miles west to Cassia County line; north to 900 south; west to Interstate 84; north to Interstate to 300 south; west to 1450 east; south to 1400 south; east to 450 east (Point of Beginning).

**OAKLEY ATTENDANCE AREA:**

**OAKLEY ELEMENTARY:** Students residing within the following boundaries: Beginning 800

south 1300 west; south to 1100 south; west to Cassia County line; south to Utah lien; east to 450 east; north to 1400 south; west to 50 west; north to 950 south; west to Highway 27; north on highway 27 to 850 south; west to 400 west; south to 100 south; west to 800 west; north to 800 south; west to 1300 west (Point of Beginning).

**OAKLEY HIGH SCHOOL:** Students residing within the following boundaries: Beginning 800 south 1300 west; south to 1100 south; west to Cassia County line; south to Utah lien; east to 450 east; north to 1400 south; west to 50 west; north to 950 south; west to Highway 27; north on highway 27 to 850 south; west to 400 west; south to 100 south; west to 800 west; north to 800 south; west to 1300 west (Point of Beginning).

**ALMO ATTENDANCE AREA:**

**ALMO ELEMENTARY SCHOOL:** Students residing within the following boundaries: Beginning 450 east 2600 south; south to Utah line; east to 1150 east; north to 2600 south; west to 450 east (Point to Beginning).
